**1. Rules:** The regatta will be governed by the 2017-2020 Racing Rules of Sailing, the prescriptions of the US Sailing Association, and the rules of the International Sunfish Class Association, except as any of these are altered by the Sailing Instructions.

**2. Eligibility and Entry:** The regatta is open to all boats of the Sunfish class.

**3. Entry Fee \$20, Junior Sailors-Free**

**4. Schedule of events:**

**5. Registration:** Competitors may register at the regatta or by completing the entry form and sending it with the appropriate fees to: Lake Bluff Yacht Club, PO Box 292, Lake Bluff, IL 60044.

**6. Sailing Instructions:** Will be available at the registration desk.

**7. Courses and Venue:** The courses may be: Windward/Leeward, Triangle, or a combination thereof. Racing will occur in the sailing waters immediately East of Lake Bluff Yacht Club, as the Race Committee in its discretion may determine.

**8. Number of Races:** Up to 7 races are scheduled. One race shall constitute a regatta.

**9. Scoring:** Scoring will be low point scoring system in accordance with Appendix A of the Racing Rules of Sailing, as may be modified by the Sailing Instructions.

**10. Prizes:** Prizes will be awarded to the top 5 finishers and the top juniors.

**11. Regatta Site:** Lake Bluff Yacht Club Compound, South Beach, Lake Bluff, IL.

**Parking Restrictions:** There is very limited parking at Lake Bluff Beach. Competitors trailering their boats will be asked to drop off their boat and park at the top of the bluff.
